enough said that a few years later, he fled back to TV. Meanwhile, he watched Jimmy Smits grab an Emmy for the role he vacated and probably wondered, "What if?"

The Betamax was the first widely available medium for recording TV at home. Technically superior to its rival, VHS, it stumbled when VHS manufacturers introduced extended play first.

Millions of stunned Betamax owners soon found Beta prerecorded tapes impossible to find and their technically superior machines sitting idle. They were later found wandering the aisles of *Circuit City* wondering, "What if?"

Poor Bob Welch. Bob quit a struggling band that had only modest success to launch a solo career. It seemed the right thing to do when his debut album had a hit single, "Sentimental Lady". Unfortunately, Bob was quickly overshadowed by the band he had departed. They had picked up a new guitarist, Lindsey Buckingham, and Lindsey's girlfriend Stevie Nicks. Their band, Fleetwood Mac, recorded an album, "Rumours" that stayed at the top of the charts for a year, retained the No. 1 position for 30 weeks on end and won the Grammy for the 19977 Album of the Year. *Rules*— The regatta will be governed by the International Yacht Racing Rules including the Sailboard Racing Rules as prescribed by the United States Sailing Association, the Rules of the International Mistral Class Organization, the printed Notice of Race and the Sailing Instructions.

*Eligibility and Entry*— The regatta is open to any age competitor. Fall Classic entrants will be scored separately for awards in IMCO, Open and Sport fleets. Seniors are 35 or older, as of October 24, 1998. Senior entrants will compete in Open and Sport fleets with age divisions. Except for the IMCO fleet, all boards are unrestricted and sails shall be 7.5m² or smaller as measured by the manufacturer.

Pre-register by completing the attached entry form and sending it with appropriate fees to the address shown. Pre-registrations **must be received** by October 20th. Pre-registrants will be entered in a drawing for a 1999 Neil Pryde Supersonic 8.1m<sup>2</sup> sail. You may late-register on October 23 or 24th at the regatta site. The late fee is \$10.
